Amendment to Class Rules – C.4.2(a)(i)

Subtitle:

Clarification of optional recording equipment

Purpose or Objective

To clarify the requirements of the class rules with regards to recording equipment, tracking devices and GPS devices.

Proposal

Amend opening introduction to C.4.2 to read as follows;

C.4.2 For the avoidance of doubt, when items listed here are worn or carried by the **crew** they shall be included for weighing under C.3.4 except when the **crew** or **boat** is required to carry equipment supplied by the OA which shall be excluded from weighing under C.3.4.

Delete existing class rule C.4.2(a)(iii) and replace with the following;

C.4.2(a)(iii) Recording equipment (sound and/or video) and personal GPS devices and any associated attachment fittings, when permitted by the Notice of Race or Sailing Instructions.

Add new class rule C.4.2(a)(iv) to read as follows;

C.4.2(a)(iv) The Notice of Race or Sailing Instructions may require a **boat** or **crew** to carry supplied recording equipment (sound and/or video), a GPS or tracking device as supplied by the Organising Authority, the Organising Authority shall provide instructions of its fitting to the **boat** or **crew**.

Current Position

C.4.2(a)(iii) Recording equipment, tracking devices and associated attachments, when permitted by the Notice of Race or Sailing Instructions may make its use mandatory when supplied. These items shall not be permanently fixed to the windsurfer.

Reason

To differentiate between providing permission for personal equipment and that supplied by an Organising Authority.
