**GENERAL RECALL**

**Subtitle:**

**SCORING - CONSISTENCY**

**Purpose or Objective**

- 1) To make the race more fair;
- 2) To clarify that when the number of the entries are 24 or less, a board scored BFD in a sprint slalom or in course race shall be scored with the same points.  
Eg. Olympic Games or a race with 24 entries or less.
- 3) To clarify when the event is split into fleets (more than 24 entries), a board that is scored BFD shall receive the points based on the format he was identified BFD.
- 4) To clarify that if an event is split into fleets, with the Opening series divided into Qualifying series and Final series a board that is scored BFD shall not carry on this penalty from the qualifying series to the finals series.
- 5) to clarify that a board that is scored BFD sprint slalom or in course race shall carry on the penalty to a marathon race.

**Proposal**

**REFERS to NoR/SI 2022 iQFOIL WORLD CHAMPIONSHIPS Brest. France**

NoR/SI item 1.12(b)

If the race committee acts under NoR/SI rule 1.12(a) and the board is identified, she shall be Disqualified without a hearing, even if the race is abandoned. The race committee shall hail or display her sail number, and she shall leave the course area immediately. If the race is restarted or resailed, she shall not sail in it **if the total number of the entries are 24 or less. The starting penalty mentioned in item 1.12(a) will be carry from sprint slalom to course race and the viceversa.**

**If the event is split into fleets, the Opening series will be divided into a Qualifying series and a Final series. The starting penalty mentioned in item 1.12(a) shall not carry on from the qualifying series to the final series.**

**In any case the penalty taken in sprint slalom or course race under item 1.12(a) shall never carry to a Marathon race.**

NoR/SI item 1.12(b)

If the race committee acts under NoR/SI rule 1.12(a) and the board is identified, she shall be Disqualified without a hearing, even if the race is abandoned.
